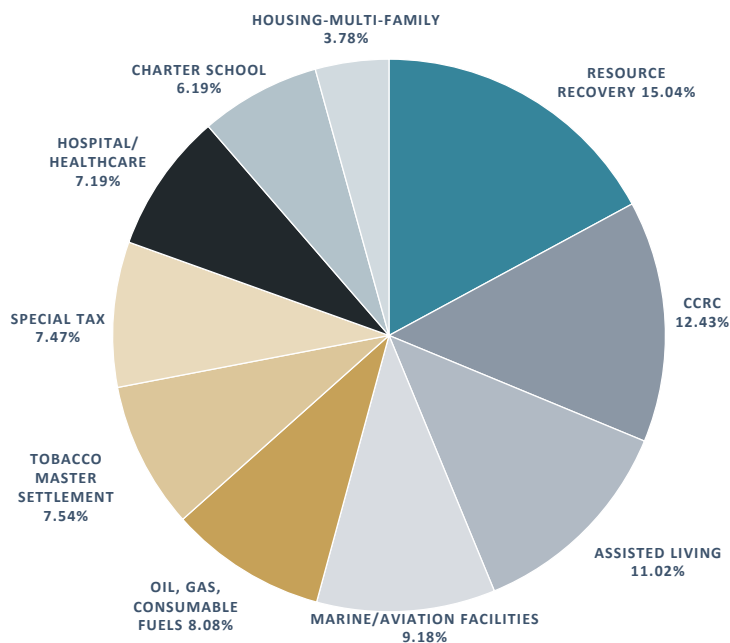

Bloomberg High Yield Municipal Index: The US Municipal Index covers the high yield portion of the USD-denominated long-term tax-exempt bond market. The index has four main sectors: state and local general obligation bonds, revenue bonds, insured bonds, and pre-refunded bonds.

Credit Rating: A Nationally Recognized Statistical Ratings Organization (NRSRO) evaluates a bond issuer's financial strength, or its ability to pay a bond's principal and interest in a timely fashion. Ratings are expressed as letters ranging from "AAA", which is the highest grade, to "D", which is the lowest grade. In limited situations when the rating agency has not issued a formal rating, the rating agency will classify the security as non-rated.

Duration is a time measure of a bond's interest-rate sensitivity, based on the weighted average of the time periods over which a bond's cash flows accrue to the bondholder. The longer a fund's duration, the more sensitive the fund is to shifts in interest rates.

Distribution Yield is the latest monthly dividend rate times 12 divided by the latest month-end NAV.
