The Fund's primary investment objective is to provide current income exempt from regular federal income tax.

INVESTMENT STRATEGY

Delivering yield-driven total return relying mostly on fundamental credit analysis, through a short duration (a measure of interest rate sensitivity), high grade, actively managed portfolio.

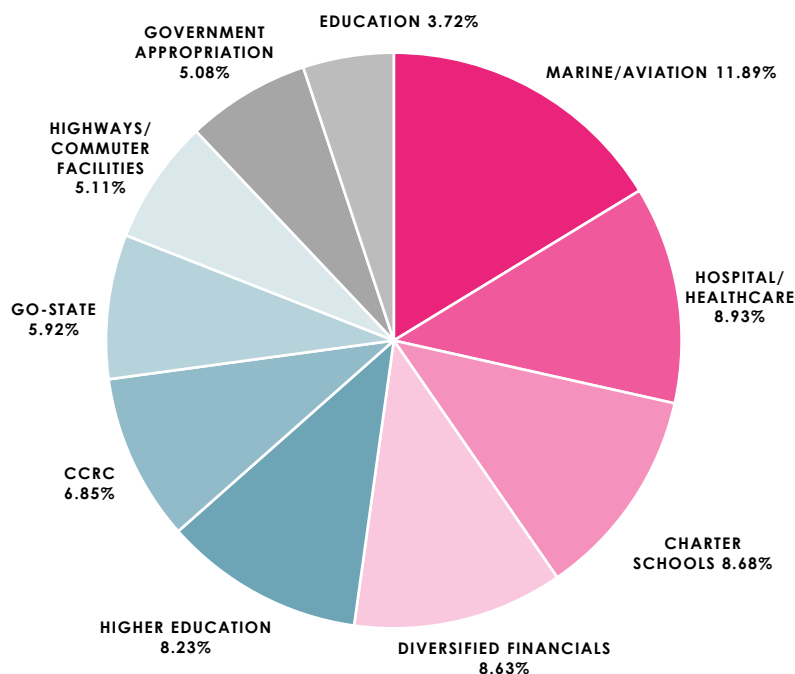

Credit Rating: A Nationally Recognized Statistical Ratings Organization (NRSRO) evaluates a bond issuer's financial strength, or its ability to pay a bond's principal and interest in a timely fashion. Ratings are expressed as letters ranging from "AAA," which is the highest grade, to "D", which is the lowest grade. In limited situations when the rating agency has not issued a formal rating, the rating agency will classify the security as non-rated.

Bloomberg 3 Year (2-4) Municipal Bond Index: The Bloomberg 3 Year (2-4) Municipal Bond Index is a rules-based, market-value-weighted index engineered for the long-term tax-exempt bond market. The Index has four main sectors: general obligation bonds, revenue bonds, insured bonds (including all insured bonds with a Aaa/AAA rating), and prefunded bonds. Most of the index has historical data to January 1980. In addition, subindices have been created based on maturity, state, sector, quality, and revenue source, with inception dates later than January 1980. The index used herein is the 3 Year (2-4) component of the Municipal Bond Index.

Duration is a time measure of a bond's interest-rate sensitivity, based on the weighted average of the time periods over which a bond's cash flows accrue to the bondholder. The longer a fund's duration, the more sensitive the fund is to shifts in interest rates.

Distribution Yield is the latest monthly dividend rate times 12 divided by the latest month-end NAV.
