

Principal Street Funds

Enclosed is the 2023 Tax Form for your account with the Principal Street Funds. The Form provides information on any applicable 2023 distributions and proceeds from redemptions. Please note that all information contained in this Statement has been provided to the Internal Revenue Service. In addition to the tax information provided on your enclosed Tax Form, below is supplemental information to assist you with the preparation of your 2023 income tax returns. Please consult your tax advisor for the specific application of any items below relating to the preparation of your tax returns.

Income subject to the Alternative Minimum Tax

Some of the income received from a mutual fund may be exempt from federal income tax, but subject to the Alternative Minimum Tax. The following table shows the percentage of total ordinary income dividends that was attributable to income earned from securities subject to the Alternative Minimum Tax:

<u>Fund Name</u>	<u>% of Income Attributable to Securities Subject to the AMT</u>
Principal Street High Income Municipal Fund	27.02%
Principal Street Short Term Municipal Fund	9.26%
